WHEREAS, the following grant from the Institution of Museum and Library Services (IMLS) FY2022 American Rescue Plan Grants Program was not anticipated when the 2021/2022 budget was approved, and

WHEREAS, Section 129.06(2)(d) of the Florida Statutes stipulates that a receipt of a nature from a source not anticipated in the budget and received for a particular purpose may, by resolution of the Board, be appropriated and expended for that purpose, and

WHEREAS, these funds are to be used to support training and curriculum for the Creation Spaces throughout the Library System.
