

CLAY COUNTY RESOLUTION NO. 2021/2022-32

WHEREAS, the following revenue from the Highway Planning and Construction Federal-Aid Highway Program through the State of Florida Department of Transportation was not anticipated when the 2021/2022 budget was approved, and

WHEREAS, Section 129.06(2)(d) of the Florida Statutes stipulates that a receipt of a nature from a source not anticipated in the budget and received for a particular purpose may, by resolution of the Board, be appropriated and expended for that purpose, and

WHEREAS, these funds are to be used by the Clay County Public Works Department for construction and construction oversight of roadway improvements on CR 209 from CR315B to Henley Road.

NOW THEREFORE BE IT RESOLVED by the Board of County Commissioners of Clay County, Florida, that pursuant to Section 129.06(2)(d) of the Florida Statutes, the following budget be adopted.
