

CLAY COUNTY RESOLUTION NO. 2022/2023- 9

WHEREAS, the following revenue from the Bureau of Justice Assistance, Office of Justice Programs, FY22 Edward Byrne Memorial Justice Assistance Grant – Local Solicitation was not anticipated when the 2022/2023 budget was approved, and;

WHEREAS, Section 129.06(2)(d) of the Florida Statutes stipulates that a receipt of a nature from a source not anticipated in the budget and received for a particular purpose may, by resolution of the Board, be appropriated and expended for that purpose, and;

WHEREAS, these funds are to be used for technological enhancements to the Clay Community Connects Program.
