

RESOLUTION NO. 2022/2023- 74

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF CLAY COUNTY, FLORIDA, ADOPTING THE TENTATIVE LEVYING OF AD VALOREM TAXES FOR CLAY COUNTY (INCLUDING SPECIAL TAXING DISTRICTS AND DEPENDENT TAXING DISTRICTS IN CLAY COUNTY) FOR FISCAL YEAR 2023-2024; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Board of County Commissioners of Clay County, Florida, on September 12, 2023, adopted Fiscal Year 2023-2024 Tentative Millage rates following a public hearing as required by Florida Statutes, Section 200.065; and

WHEREAS, the Board of County Commissioners of Clay County, Florida, held a public hearing as required by Florida Statutes, Section 200.065; and

WHEREAS, the gross taxable value for operating purposes not exempt from taxation has been certified by the County Property Appraiser to the Board of County Commissioners as \$16,931,457,579.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Clay County, Florida, that:

The Fiscal Year 2023-2024 aggregate operating millage rate is 8.3661 mills which is more than the current year aggregate rolled-back rate of 7.4676 mills by 12.03%.

The operating millage rates are broken down as follows:

<i>Unincorporated Services MSTU Fund</i>	<i>0.1477 mills</i>
<i>Law Enforcement MSTU-4 Fund</i>	<i>2.4014 mills</i>

<i>Lake Asbury MSBD</i>	<i>0.0000 mills</i>
<i>Challenger Center MSTU</i>	<i>3.0000 mills</i>
