

**CLAY COUNTY RESOLUTION NO. 2023/2024- 27**

**WHEREAS**, the following revenue from the Department of Justice (DOJ), Bureau of Justice Assistance (BJA), FY23 Edward Byrne Memorial Justice Assistance (JAG) Grant - Local Solicitation was not anticipated when the 2023/2024 budget was approved, and

**WHEREAS**, Section 129.06(2)(d) of the Florida Statutes stipulates that a receipt of a nature from a source not anticipated in the budget and received for a particular purpose may, by resolution of the Board, be appropriated and expended for that purpose, and

**WHEREAS**, these funds are to be used to support the Clay Community Connect Program and expand the operations of the Real Time Crime Center by acquiring fourteen (14) additional PTZ cameras.

**NOW THEREFORE BE IT RESOLVED** by the Board of County Commissioners of Clay County, Florida, that pursuant to Section 129.06(2)(d) of the Florida Statutes, the following budget be adopted.
