A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF CLAY COUNTY, FLORIDA, CERTIFYING THE MAXIMUM MILLAGE FOR FISCAL YEAR 2024-2025; SETTING THE TENTATIVE BUDGET HEARING FOR SEPTEMBER 10, 2024 AT 5:05 P.M.; AUTHORIZING THE COUNTY MANAGER TO EXECUTE THE CERTIFICATIONS OF TAXABLE VALUE; AND PROVIDING AN EFFECTIVE DATE.

RE: CERTIFICATION OF MAXIMUM MILLAGE – FISCAL YEAR 2024-2025

WHEREAS, in compliance with Chapters 129 and 200, Florida Statutes, tentative budgets for Clay County have been prepared; and

WHEREAS, the proposed Clay County Budget for the Fiscal Year 2024-2025 requires the imposition of ad valorem taxes to support Clay County countywide operations, other dependent special districts, and MSTUs.

NOW THEREFORE, BE IT RESOLVED, BY THE CLAY COUNTY BOARD OF COUNTY COMMISSIONERS, that:

1. The maximum ad valorem millages shown in Attachment B are hereby certified for the Fiscal Year 2024-2025 and the tentative budget hearing is set for September 10, 2024 at 5:05 p.m.
2. Pursuant to Section 200.065, Florida Statutes, the County Manager is hereby authorized to execute Certifications of Taxable Value.
3. This Resolution shall take effect immediately upon adoption.
