Clay County has identified \$828,129.01 in unused funds from its FY 2021-2022 Community Development Block Grant (CDBG) Annual Action Plan entitlement award that it would like to add to its FY 2023-2024 Annual Action Plan for new infrastructure projects in low- and moderate-income areas of the County. The FY 2021-2025 Consolidated Plan and the FY 2023-2024 Annual Action Plan have been revised to include this additional funding amount under the Public Infrastructure project, which includes street improvements and sidewalks. The Citizen Participation Plan has been revised to identify a change in the point of contact from the Planning and Zoning Director to Community and Social Services. These Plans will be available for 30-day public review and comment period and one public hearing will be held during the Board of County Commissioners meeting on Tuesday, March 26, 2024, as set forth below.

Clay County, Florida is a newly entitled community and received Community Development Block Grant (CDBG) Funds through the U.S. Department of Housing and Urban Development (HUD) for the first time on October 1, 2021. With CDBG funds, Clay County will work to promote affordable housing initiatives and create a suitable living environment for low- to moderate- income households. This Annual Action Plan outlines the program goals and funding for various projects for the 2023-24 fiscal year beginning on October 1, 2023. The priority needs of the County are addressed through activities developed in the Annual Action Plan that work towards accomplishing the established goals associated with the identified needs. By addressing these priority needs, the County can improve the quality of life of residents in Clay County.

Outcome: Affordability-Housing Rehabilitated: 10 Households/Housing Units; Rental Units.

Code enforcement

Code enforcement in distressed neighborhoods defined as more than 51% low- and moderate-income in the County.

Objective: Suitable Living Environment (SL)-Provide funding for the payment of salaries and overhead costs directly related to the enforcement of local codes in deteriorating or deteriorated areas in Target Areas.

Outcome: Availability/Accessibility-Housing Code Enforcement/Foreclosed Property Care: 15 Households/Housing Units.

Neighborhood Improvements

Infrastructure projects in distressed neighborhoods defined as more than 51% low- and moderate-income in the County.

Objective: Provide funding for public facility improvements, physical improvements, and comprehensive neighborhood planning activities in Target Areas, and HUD designated Low-Mod Areas to improve the quality of life and health of neighborhood residents. Specific projects include street improvements, sidewalks, and neighborhood cleanups.

Outcome: Sustainability: Promoting Livable or Viable Communities-Public Facility or Infrastructure Activities other than Low/Moderate Income Housing Benefit: 100 Persons Assisted.

3. Evaluation of past performance

This is an evaluation of past performance that helped lead the grantee to choose its goals or projects.

Fiscal year 2021-22 was the first year of Clay County entitlement under the CDBG program and emphasis was placed on neighborhood improvement projects and establishing a process for preservation of housing activities (application intake and review, home inspections, etc.). More data will be available by the time the County conducts its second evaluation of past performance in late fall of 2023 during the CAPER (Consolidated Annual Performance and Evaluation Report) process.

4. Summary of Citizen Participation Process and consultation process

Summary from citizen participation section of plan.

Clay County staff conducted three public meetings in various locations of the county to encourage citizen participation in areas of low- and moderate- income residents, as well as those not wishing or able to drive to the County seat.

The County held a public comment period from June 9, 2023, through July 8, 2023, to allow opportunity for the public to review the proposed Annual Action Plan. The Plan was made available on the County's website and social media. The Plan was also available at the five (5) Clay County Public Libraries and at the County Administration Building for those wishing to view the Plan in paper form. The public was invited to submit comments to the County's Planning & Zoning Department by email or phone. Furthermore, two (2) public hearings were held, on June 13, 2023, and on July 25, 2023, during which the public was invited to watch and/or attend and provide comment prior to the adoption of the Annual Action Plan at the July 25th public hearing.

5. Summary of public comments

The County received eight emailed comments during the public comment period. However, these comments were not directly related to the County's CDBG activities and were not accepted. There were numerous questions related to the Annual Action plan raised at the three public meetings. Most were related to understanding the plan and the CDBG process. At each public meeting, participants were asked to rank the proposed funding categories in order from what they felt was most important to least important. The public's ranking matched the funding order that staff proposed in the original draft.

A summary of the emailed comments that were not directly related to developing the 2023-24 Annual Action Plan and were not accepted into the Plan are provided below:

- Concerns about traffic and lane widening on CR 220
- Concerns about the rising costs of rental properties
- Concerns about preserving the natural environment and slowing new construction
- Concerns about traffic and new construction
- Concerns about new construction and lot sizes; recommend new developers use heat pumps and solar shingles/solar panels
- Concerns about safety in the High Ridge Estates community
- Additional law enforcement for the western part of the county
- Accountability for landlords to maintain rental property to livable standards

- 1) Housing rehabilitation \$350,000.00
- 2) Code Enforcement and Neighborhood Cleanups: \$50,000.00

To reach out to a larger portion of the population, especially those of low- and moderate- income, the notice of all meetings/hearings related to the County's proposed Action Plan as well as the 30-day public comment period were advertised in the local newspaper, the County's website and social media in both English and Spanish. Three (3) public meetings were held in various locations of the county to reach a larger portion of the population in a face-to-face format. Sign language and spoken language interpreters were made available to the public for all meetings/hearings and a TDD number was available for any person with a hearing impairment. The meetings/hearings were recorded and made available for the public to watch with closed-captioning through the County's website for anyone not able to attend any of the in-person meetings.

Summarize citizen participation process and how it impacted goal-setting

Comments received during the public meetings and by email during the public comment period highlighted new sidewalk locations for County staff to consider in the infrastructure program portion of the FY 2022-23 Annual Action Plan. These were combined with the list provided by staff and reconsidered based on cost, completion time, and projected benefit. The input from residents who are more intimately connected to areas of the county not normally traveled by staff is invaluable to the project selection process.

In the preparation of the FY 2023-24 Annual Action Plan, infrastructure remained the public's number one funding priority; staff has retained sidewalk replacement projects in its FY 2023-24 Annual Action Plan to provide safe public access to critical services in LMI areas.

All Activities supported by the County's Five-Year Consolidated Plan strive to improve the quality of life for Clay County low-to-moderate income residents located within Clay County's unincorporated areas, as well as 4 municipalities (Town of Orange Park, City of Green Cove Springs, Town of Penney Farms, City of Keystone Heights). Clay County faces barriers to affordable housing that are common across housing markets, including limited supply of developable (e.g., zoned) land particularly for multi-family rental housing, which increases the cost of acquisition and development of the land. Also, few resources exist beyond Low Income Housing Tax Credits to provide the appropriate subsidy for development of affordable rental housing.

Another common barrier is negative reaction from neighbors regarding affordable housing development based upon a misconception that property values will decline and an increase in parking and traffic. Finally, while the economy is strong in Clay County, incomes are not rising high enough and fast enough to meet the cost of single-family homeownership.

Clay County has identified several governmental constraints to the development, maintenance, and improvement of housing and affordable housing, as follows: Zoning Code Amendments, Lot Consolidation, and Monitoring of Planning and Development Fees. Nongovernmental constraints were identified as follows: Land Costs, Construction Costs, and Availability of Financing. Clay County will continue to review and examine all real and perceived barriers to affordable housing and seek to remove or ameliorate them.

Actions planned to address obstacles to meeting underserved needs

The obstacles that Clay County faces are barriers to affordable housing including lack of funding (federal, state, local) for affordable housing, limited land availability, high utility/maintenance costs in older housing units, cost prohibitive tree/landscaping requirements, aging mobile home parks, smaller units in demand but not cost feasible to construct, and tenant barriers including Fair Housing issues. In terms of specific gaps, most needs are generally met in some way through community partners; however, the amount of need almost always outweighs the available funding. More specific deficits in the quantity and quality of affordable housing were identified during the citizen participation process. Affordable housing continues to be a concern for Clay County, primarily due to the widening gap between median income and median home values and rents, and due to limited land availability. Related to housing affordability, homelessness also continues to be an area of concern. Underserved populations in Clay County include the elderly; mental illness, or substance abuse/addiction challenges; and persons with disabilities. The County continues to coordinate with a network of community partners and the Continuum of Care (CoC) to address these needs as funding allows.

Actions planned to foster and maintain affordable housing

Fostering and maintaining affordable housing that may be lost from the assisted housing inventory is a high priority for the County. The County will use CDBG and other funding to:

- Provide Housing Counseling and Education to low-to moderate-income households. State SHIP funds will also be used to aid households.
- Preservation of the existing housing stock through acquisition and/or rehabilitation of owner or renter housing for low-to moderate-income households using CDBG funds. State SHIP will also be used to preserve additional units.
- Production of new affordable housing through rehabilitation.

Actions planned to reduce lead-based paint hazards

The Florida Department of Health (DOH) is the primary agency for addressing lead-based paint (LBP)

hazards in Clay County. Budgetary constraints have limited lead screening and case management activities; however, the DOH still responds to reported cases of lead poisoning as determined by local pediatricians and health care providers.

The DOH, authorized under the Florida Lead Poisoning Prevention Screening & Education Act, Section 381.985, F.S., and Chapter 64D-3, F.A.C., conducts surveillance of Blood Lead Level (BLL) testing and poisonings in the County, promotes BLL screening for high-risk populations, and provides information to health care providers, individuals, and businesses on lead poisoning prevention. Program activities include surveillance and epidemiology, lead poisoning investigations, primary prevention, and coordinate of care if a person or family is found to have high BLL. The DOH also disseminates information to parents and caregivers, healthcare providers, and renovators and contractors about LBP hazards and screening options. This information includes brochures on keeping children safe from LBP hazards, sources of lead, remediation tactics, and adult lead poisoning prevention at home and in the workplace.

To address LBP hazards, the DOH in Clay County performs BLL testing and coordinates follow-up care if elevated BLL is detected. For children identified with elevated BLL, a lead assessment of the home is recommended. A specialist performs inspections and risk assessments at no charge for families with children having elevated BLL, family day care homes, and day care centers. The DOH in Clay County also works to identify LBP hazards in the environment in conjunction with housing demolition, rehabilitation, and redevelopment activities in older neighborhoods. The primary source of lead exposure among children is LBP in older, deteriorating buildings.

Actions planned to reduce the number of poverty-level families

Clay County's strategy to reduce the number of poverty-level families is multi-faceted and relies on the cooperation of numerous partners throughout the County and greater Jacksonville region. These partners include County departments, economic development partners such as the Economic Development Corporation and the regional JAXUSA, public service providers, the Continuum of Care, housing authorities, public and private organizations (e.g., non-profits and community development corporations), and other stakeholders in community development activities. These stakeholders will work in concert to address a variety of interrelated social issues, including disparities in education and training, unemployment, limited access to healthcare, family instability, criminal background, inadequate housing, deteriorating neighborhoods, and transportation disadvantage.

The County's goals are to address the categories of affordable housing, homelessness, non-homeless special needs, and non-housing community development are all anti-poverty strategies. Clay County will connect poverty-level individuals and families with publicly available services, including healthcare resources, emergency financial assistance, housing assistance, justice coordination, senior/elderly services, and social security and disability benefits. These programs support social and economic stability for residents, particularly those with special needs. Economic Development Partners offer

employment and job skills/workforce training programs for low- and moderate-income individuals. Such partners include Clay CareerSource. The Salvation Army, Goodwill Industries, among others can also connect poverty-level persons and persons with disabilities with employment opportunities. Beyond any Countywide program or initiative, Clay County also supports HUD's Office of Economic Resilience strategies for enhancing equity and inclusion. Within Clay County, there is a disproportionate percentage of poverty-level individuals among minority racial and ethnic groups (2013-2017 ACS). Therefore, anti-poverty strategies must also address equity, inclusion, and fair housing. HUD's equity and inclusion strategies include building inclusive government structures; identifying regional barriers to opportunity; prioritizing investments to equalize opportunity; and improving the location of transportation assets to improve access to employment.

Actions planned to develop institutional structure

Clay County is the lead agency in administering the CDBG grant funds. Clay County's Planning Office has a strong support system internally and externally. The Public Works and Engineering Departments work with various neighborhood/resident committees to obtain requests for projects such as sidewalks, parks improvements, areas in need of improved drainage, road improvements, and other community development needs. Clay County works closely with local nonprofit organizations to implement various public services activities.

In terms of specific gaps, most needs are generally met in some way through these community partners; however, the amount of need almost always outweighs the available funding. More specific deficits in the quantity and quality of affordable housing were identified during the citizen participation process. Affordable housing continues to be a concern for Clay County, primarily due to the widening gap between median income and median home values and rents, and due to limited land availability. Related to housing affordability, homelessness also continues to be an area of concern. Underserved populations in Clay County include the elderly, persons with mental illness, or substance abuse/addiction challenges, and persons with disabilities. The County continues to coordinate with a network of community partners and the Continuum of Care (CoC) to address these needs as funding allows.

Clay County will continue to network with participating cities and towns, elected officials, citizens, non-profit and for-profit stakeholders, and the Continuum of Care (CoC) to identify community needs, make these needs widely known to stakeholders, and identify projects or programs and funding opportunities to address these needs. To improve the preservation and production of affordable housing within Clay County, the County plans to emphasize a transit-oriented/activity center development framework that will foster affordable housing proximate to transportation and employment opportunities. The County will also utilize leveraging and matching of federal funding, particularly with state and local funding sources such as SHIP that are specifically designated for housing and/or economic development activities. The preservation and production of affordable housing, as well as housing/rental assistance, is overseen by the Clay County Planning Department's Community Development Division and

implemented through a network of non-profit and for-profit housing developers and organizations.

To improve the funding of public services, particularly for homeless and special needs populations, the County will support the CoC member organizations in the development of projects or programs that address priority needs and encourage applicant subrecipients to leverage and match federal funding with state and local funding sources to address priority needs. Such investment will be focused in areas of concentrated poverty, such as the Target Areas identified previously. The provision of public services will be overseen by the Community Development Division.

Actions planned to enhance coordination between public and private housing and social service agencies

Key agencies that are additional resources that may be available are described below. The County's Community and Social Services Division works with private sector partners to coordinate actions and address the public's requests for assistance.

Public Sector

The Community and Social Services Division which includes Veterans Services, Animal Services, Volunteer/SWEAT Coordinator, and Rental Assistance Lead will assist as needed in getting those in need the assistance that they require. Clay County Health Department offers a variety of services and programs to residents such as childcare licensing, childhood lead poisoning, family planning, WIC, and women's health, among others. Flagler County Housing Authorities administers Clay County's Section 8 Voucher Program. A host of non-profit agencies that serve target income households within the County. A coordinated effort is necessary to facilitate service provisions to varying groups throughout the County. As members of the Consortium, Cooperating Cities will be instrumental in accomplishing identified goals and activities.

Private Sector

The private sector is an important collaborator bringing additional resources and expertise that can be used to supplement existing services or fill gaps in the system. Lenders, affordable housing developers, business and economic development organizations, and private service providers offer a variety of assistance to residents such as health care, small business assistance, residential mortgage programs,

commercial lending and assisted housing, among others.

Discussion:

The County is committed to continuing its participation and coordination with Federal, State, municipal and local agencies, as well as with the private and non-profit sector, to serve the needs of target income individuals and families in the County. In particular, the County will continue to work in close coordination with County departments regarding infrastructure improvements and the provision of services.

The allocation of priorities for housing activities (i.e., rehabilitation), code enforcement and infrastructure improvements were determined through several processes including but not limited to public hearings, outreach and listening sessions and a citizen survey to gauge the activities and projects the public deemed important. The proposed housing activities (i.e., rehabilitation), code enforcement and infrastructure improvements that will take place in low- and moderate-income areas of Clay County are critical to sustaining the quality of life of residents and businesses in the area. This decision allows improvements to be directed to a concentrated area utilizing the limited CDBG resources available. The limiting factor in addressing underserved needs in Clay County are the lack of sufficient CDBG funding allocations as well as other resources to address all the needs.

WHEREAS, Clay County (the County) has been designated an Entitlement Grantee as a "Qualified Urban County" by the United States Department of Housing and Urban Development (HUD), which entitles the County to receive an annual allocation of Community Development Block Grant (CDBG) Funds directly from HUD to implement housing and community development projects throughout the County; and

WHEREAS, the County's 2021 - 2025 CDBG Consolidated Plan was adopted by the County and approved by HUD; and

WHEREAS, the County's FY 2023-2024 CDBG Annual Action Plan, attached hereto as Exhibit A, was made available for public review and comment and public meetings and hearings were held in accordance with the County's Citizen Participation Plan; and

WHEREAS, the County anticipates receiving CDBG funds in the amount of \$1,020,627 during FY 2023-2024; and

WHEREAS, the County desires to receive the annual allotment of CDBG funds from HUD so that various community development projects may be completed; and

WHEREAS, the County finds that approving the FY 2023-2024 Annual Action Plan is in the best interest of the health, safety, and welfare of the citizens and residents of the County.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF CLAY COUNTY, FLORIDA, AS FOLLOWS:

- Section 1. The above recitals are true and correct and are incorporated herein by reference.
- Section 2. The County's FY 2023-2024 CDBG Annual Action Plan attached hereto as Exhibit A is hereby approved.
- Section 3. The following proposed allocations of CDBG entitlement funds estimated to be available for FY 2023-2024 totaling \$1,020,627.00 are hereby approved:

Housing Rehabilitation \$350,000.00
 Public Infrastructure \$523,450.00
 Code Enforcement \$50,000.00
 Program Administration \$97,177.00

As the proposed allocations are based upon estimated funding, it is further recognized that the allocations may need to be proportionately adjusted from estimated funding levels to match actual levels.

Section 4. The County Manager is hereby authorized and directed to transmit to HUD this Resolution, the County's FY 2023-2024 Annual Action Plan along with all other required documentation, and is further authorized to execute any and all applications, certifications, grant contracts, agreements, funding approval, amendments, modifications, and other documents on behalf of the County related to the County's CDBG Program and funding for FY 2023-2024.

Section 5. All resolutions inconsistent or in conflict herewith shall be and are hereby repealed insofar as there is conflict or inconsistency.

AP-05 Executive Summary

1. Introduction

Clay County, Florida is a newly entitled community and received Community Development Block Grant (CDBG) Funds through the U.S. Department of Housing and Urban Development (HUD) for the first time on October 1, 2021. With CDBG funds, Clay County will work to promote affordable housing initiatives and create a suitable living environment for low- to moderate- income households. This Annual Action Plan outlines the program goals and funding for various projects for the 2023-24 fiscal year beginning on October 1, 2023. The priority needs of the County are addressed through activities developed in the Annual Action Plan that work towards accomplishing the established goals associated with the identified needs. By addressing these priority needs, the County can improve the quality of life of residents in Clay County.

Summary of the objectives and outcomes identified in the Plan Needs Assessment Overview

Clay County has identified the following priority needs with associated goals to address the needs:

Preservation of housing

Housing rehabilitation including homes owned by low- and moderate-income individuals and replacement of mobile homes owned by low- and moderate-income individuals.

Objective: Decent Housing (DH)-Provide funding for the acquisition and/or rehabilitation/preservation of housing affordable to low- and moderate-income residents.

Outcome: Affordability-Housing Rehabilitated: 10 Households/Housing Units; Rental Units.

Code enforcement

 $Code\ enforcement\ in\ distressed\ neighborhoods\ defined\ as\ more\ than\ 51\%\ low-\ and\ moderate-income\ in\ the\ County.$

Objective: Suitable Living Environment (SL)-Provide funding for the payment of salaries and overhead costs directly related to the enforcement of local codes in deteriorating or deteriorated areas in Target Areas.

Outcome: Availability/Accessibility-Housing Code Enforcement/Foreclosed Property Care: 15 Households/Housing Units.

Neighborhood Improvements

Infrastructure projects in distressed neighborhoods defined as more than 51% low- and moderate-income in the County.

Objective: Provide funding for public facility improvements, physical improvements, and comprehensive neighborhood planning activities in Target Areas, and HUD designated Low-Mod Areas to improve the quality of life and health of neighborhood residents.

Outcome: Sustainability: Promoting Livable or Viable Communities-Public Facility or Infrastructure Activities other than Low/Moderate Income Housing Benefit: 100 Persons Assisted.

3. Evaluation of past performance

Fiscal year 2021-22 was the first year of Clay County entitlement under the CDBG program and emphasis was placed on neighborhood improvement projects and establishing a process for preservation of housing activities (application intake and review, home inspections, etc.). More data will be available by the time the County conducts its second evaluation of past performance in late fall of 2023 during the CAPER (Consolidated Annual Performance and Evaluation Report) process.

4. Summary of citizen participation process and consultation process

Clay County staff conducted three public meetings in various locations of the county to encourage citizen participation in areas of low- and moderate- income residents, as well as those not wishing or able to drive to the County seat.

The County held a public comment period from June 9, 2023, through July 8, 2023, to allow opportunity for the public to review the proposed Annual Action Plan. The Plan was made available on the County's website and social media. The Plan was also available at the five (5) Clay County Public Libraries and at the County Administration Building for those wishing to view the Plan in paper form. The public was invited to submit comments to the County's Planning & Zoning Department by email or phone. Furthermore, two (2) public hearings were held, on June 13, 2023, and on July 25, 2023, during which the public was invited to watch and/or attend and provide comment prior to the adoption of the Annual Action Plan at the July 25th public hearing.

5. Summary of public comments

In addition to attendee participation at the public meetings, the County received eight emailed comments during the public comment period. However, most of these comments were not directly related to the County's CDBG activities and were not accepted; a summary of these comments are provided in the response to question six below.

Comments that were considered and answered by staff include:

- Request for CDBG home rehab assistance; this request was sent to the Community and Social Services Department
- Question regarding application process for CDBG home rehab program; staff responded to this individual.

There were numerous questions related to the Annual Action Plan raised at the three public meetings. Several were related to understanding the plan and the CDBG process. At each public meeting, participants were asked to rank the proposed funding categories in order from what they felt was most important to least important. The public's ranking matched the funding order that staff proposed in the original draft: 1) infrastructure, 2) housing rehabilitation, 3) code enforcement, 4) administration.

6. Summary of comments or views not accepted and the reasons for not accepting them

A summary of the emailed comments that were not directly related to developing the 2023-24 Annual Action Plan and were not accepted into the Plan are provided below:

- · Concerns about traffic and lane widening on CR 220
- · Concerns about the rising costs of rental properties
- Concerns about preserving the natural environment and slowing new construction
- Concerns about traffic and new construction
- Concerns about new construction and lot sizes; recommend new developers use heat pumps and solar shingles/solar panels
- Concerns about safety in the High Ridge Estates community

7. Summary

Based on feedback received during the public comment period, County staff recommends adopting the proposed CDBG activity/project allocations as follows:

- 1) Housing rehabilitation \$350,000.00
- 2) Code Enforcement \$50,000.00
- 3) Public Infrastructure \$523,450.00
- 4) Program Administration \$97,177.00

The CPP encourages citizens to participate in all stages of the planning process including the identification of needs, establishing community priorities, funding allocation, and the implementation and eventual evaluation of program activities. To reach out to a larger portion of the population, especially those of low- and moderate-income, the notice of all meetings/hearings related to the County's proposed Action Plan as well as the 30-day public comment period were advertised in the local newspaper, the County's website and social media in both English and Spanish. Three (3) public meetings were held in various locations of the county to reach a larger portion of the population in a face-to-face format. Sign language and spoken language interpreters were made available to the public for all meetings/hearings and a TDD number was available for any person with a hearing impairment. The meetings/hearings were recorded and made available for the public to watch with closed-captioning through the County's website for anyone not able to attend any of the in-person meetings.

Summarize citizen participation process and how it impacted goal-setting

Comments received during the public meetings and by email during the public comment period highlighted new sidewalk locations for County staff to consider in the infrastructure program portion of the FY 2022-23 Annual Action Plan. These were combined with the list provided by staff and reconsidered based on cost, completion time, and projected benefit. The input from residents who are more intimately connected to areas of the county not normally traveled by staff is invaluable to the project selection process.

In the preparation of the FY 2023-24 Annual Action Plan, infrastructure remained the public's number one funding priority; staff has retained sidewalk replacement projects in its FY 2023-24 Annual Action Plan to provide safe public access to critical services in LMI areas.

All Activities supported by the County's Five-Year Consolidated Plan strive to improve the quality of life for Clay County low-to-moderate income residents located within Clay County's unincorporated areas, as well as 4 municipalities (Town of Orange Park, City of Green Cove Springs, Town of Penney Farms, City of Keystone Heights). It also includes the census-designated places of Asbury Lake, Bellair-Meadowbrook Terrace, Fleming Island, Lakeside, Middleburg, Oakleaf Plantation, and the unincorporated areas of Bellair, Clay Hill, Doctors Inlet, Fleming Island, Hibernia, Kingsley Lake, Lake Asbury, Lake Geneva, McRae, Meadowbrook Terrace, Melrose, and Virginia Village.

Clay County faces barriers to affordable housing that are common across housing markets, including limited supply of developable (e.g., zoned) land particularly for multi-family rental housing, which increases the cost of acquisition and development of the land. Also, few resources exist beyond Low Income Housing Tax Credits to provide the appropriate subsidy for development of affordable rental housing.

Another common barrier is negative reaction from neighbors regarding affordable housing development based upon a misconception that property values will decline and an increase in parking and traffic. Finally, while the economy is strong in Clay County, incomes are not rising high enough and fast enough to meet the cost of single-family homeownership.

Clay County has identified several governmental constraints to the development, maintenance, and improvement of housing and affordable housing, as follows: Zoning Code Amendments, Lot Consolidation, and Monitoring of Planning and Development Fees. Nongovernmental constraints were identified as follows: Land Costs, Construction Costs, and Availability of Financing. Clay County will continue to review and examine all real and perceived barriers to affordable housing and seek to remove or ameliorate them.

Listed below are the actions planned to address obstacles to meeting underserved needs, foster and maintain affordable housing, reduce lead-based paint hazards, reduce the number of poverty-level families, develop institutional structure, and enhance coordination between public and private housing and social service agencies.

Actions planned to address obstacles to meeting underserved needs

The obstacles that Clay County faces are barriers to affordable housing including lack of funding (federal, state, local) for affordable housing, limited land availability, high utility/maintenance costs in older housing units, cost prohibitive tree/landscaping requirements, aging mobile home parks, smaller units in demand but not cost feasible to construct, and tenant barriers including Fair Housing issues. In terms of specific gaps, most needs are generally met in some way through community partners; however, the amount of need almost always outweighs the available funding. More specific deficits in the quantity and quality of affordable housing were identified during the citizen participation process. Affordable housing continues to be a concern for Clay County, primarily due to the widening gap between median income and median home values and rents, and due to limited land availability. Related to housing affordability, homelessness also continues to be an area of concern. Underserved populations in Clay County include the elderly; mental illness, or substance abuse/addiction challenges; and persons with disabilities. The County continues to coordinate with a network of community partners and the Continuum of Care (CoC) to address these needs as funding allows.

Actions planned to foster and maintain affordable housing

Fostering and maintaining affordable housing that may be lost from the assisted housing inventory is a high priority for the County. The County will use CDBG and other funding to:

- Provide Housing Counseling and Education to low-to moderate-income households. State SHIP funds will also be used to aid households.
- Preservation of the existing housing stock through acquisition and/or rehabilitation of owner or renter housing for low-to moderate-income households using CDBG funds. State SHIP will also be used to preserve additional units.
- · Production of new affordable housing through rehabilitation.

Actions planned to reduce lead-based paint hazards

The Florida Department of Health (DOH) is the primary agency for addressing lead-based paint (LBP) hazards in Clay County. Budgetary constraints have limited lead screening and case management activities; however, the DOH still responds to reported cases of lead poisoning as determined by local pediatricians and health care providers.

The DOH, authorized under the Florida Lead Poisoning Prevention Screening & Education Act, Section 381.985, F.S., and Chapter 64D-3, F.A.C., conducts surveillance of Blood Lead Level (BLL) testing and poisonings in the County, promotes BLL screening for high-risk populations, and provides information to health care providers, individuals, and businesses on lead poisoning prevention. Program activities include surveillance and epidemiology, lead poisoning investigations, primary prevention, and coordinate of care if a person or family is found to have high BLL. The DOH also disseminates information to parents and caregivers, healthcare providers, and renovators and contractors about LBP hazards and screening options. This information includes brochures on keeping children safe from LBP hazards, sources of lead, remediation tactics, and adult lead poisoning prevention at home and in the workplace.

To address LBP hazards, the DOH in Clay County performs BLL testing and coordinates follow-up care if elevated BLL is detected. For children identified with elevated BLL, a lead assessment of the home is recommended. A specialist performs inspections and risk assessments at no charge for families with children having elevated BLL, family day care homes, and day care centers. The DOH in Clay County also works to identify LBP hazards in the environment in conjunction with housing demolition, rehabilitation, and redevelopment activities in older neighborhoods. The primary source of lead exposure among children is LBP in older, deteriorating buildings.

Actions planned to reduce the number of poverty-level families

Clay County's strategy to reduce the number of poverty-level families is multi-faceted and relies on the cooperation of numerous partners throughout the County and greater Jacksonville region. These partners include County departments, economic development partners such as the Economic Development Corporation and the regional JAXUSA, public service providers, the Continuum of Care, housing authorities, public and private organizations (e.g., non-profits and community development corporations), and other stakeholders in community development activities. These stakeholders will work in concert to address a variety of interrelated social issues, including disparities in education and training, unemployment, limited access to healthcare, family instability, criminal background, inadequate housing, deteriorating neighborhoods, and transportation disadvantage.

The County's goals are to address the categories of affordable housing, homelessness, non-homeless special needs, and non-housing community development are all anti-poverty strategies. Clay County will connect poverty-level individuals and families with publicly available services, including healthcare resources, emergency financial assistance, housing assistance, justice coordination, senior/elderly services, and social security and disability benefits. These programs support social and economic stability for residents, particularly those with special needs. Economic Development Partners offer employment and job skills/workforce training programs for low- and moderate-income individuals. Such partners include Clay CareerSource. The Salvation Army, Goodwill Industries, among others can also connect poverty-level persons and persons with disabilities with employment opportunities. Beyond any Countywide program or initiative, Clay County also supports HUD's Office of Economic Resilience strategies for enhancing equity and inclusion. Within Clay County, there is a disproportionate percentage of poverty-level individuals among minority racial and ethnic groups (2013-2017 ACS). Therefore, antipoverty strategies must also address equity, inclusion, and fair housing. HUD's equity and inclusion strategies include building inclusive government structures; identifying regional barriers to opportunity; prioritizing investments to equalize opportunity; and improving the location of transportation assets to improve access to employment.

Actions planned to develop institutional structure

Clay County is the lead agency in administering the CDBG grant funds. Clay County's Planning Office has a strong support system internally and externally. The Public Works and Engineering Departments work with various neighborhood/resident committees to obtain requests for projects such as sidewalks, parks improvements, areas in need of improved drainage, road improvements, and other community development needs. Clay County works closely with local nonprofit organizations to implement various public services activities.

In terms of specific gaps, most needs are generally met in some way through these community partners; however, the amount of need almost always outweighs the available funding. More specific deficits in the quantity and quality of affordable housing were identified during the citizen participation process. Affordable housing continues to be a concern for Clay County, primarily due to the widening gap between median income and median home values and rents, and due to limited land availability. Related to housing affordability, homelessness also continues to be an area of concern. Underserved populations in Clay County include the elderly, persons with mental illness, or substance abuse/addiction challenges, and persons with disabilities. The County continues to coordinate with a network of community partners and the Continuum of Care (CoC) to address these needs as funding allows.

Clay County will continue to network with participating cities and towns, elected officials, citizens, non-profit and for-profit stakeholders, and the Continuum of Care (CoC) to identify community needs, make these needs widely known to stakeholders, and identify projects or programs and funding opportunities to address these needs. To improve the preservation and production of affordable housing within Clay County, the County plans to emphasize a transit-oriented/activity center development framework that will foster affordable housing proximate to transportation and employment opportunities. The County will also utilize leveraging and matching of federal funding, particularly with state and local funding sources such as SHIP that are specifically designated for housing and/or economic development activities. The preservation and production of affordable housing, as well as housing/rental assistance, is overseen by the Clay County Planning Department's Community Development Division and implemented through a network of non-profit and for-profit housing developers and organizations.

To improve the funding of public services, particularly for homeless and special needs populations, the County will support the CoC member organizations in the development of projects or programs that address priority needs and encourage applicant subrecipients to leverage and match federal funding with state and local funding sources to address priority needs. Such investment will be focused in areas of concentrated poverty, such as the Target Areas identified previously. The provision of public services will be overseen by the Community Development Division.

Actions planned to enhance coordination between public and private housing and social service agencies

Key agencies that are additional resources that may be available are described below. The County's Community and Social Services Division works with private sector partners to coordinate actions and address the public's requests for assistance.

Public Sector

The Community and Social Services Division which includes Veterans Services, Animal Services, Volunteer/SWEAT Coordinator, and Rental Assistance Lead will assist as needed in getting those in need the assistance that they require. Clay County Health Department offers a variety of services and programs to residents such as childcare licensing, childhood lead poisoning, family planning, WIC, and women's health, among others. Flagler County Housing Authorities administers Clay County's Section 8 Voucher Program. A host of non-profit agencies that serve target income households within the County. A coordinated effort is necessary to facilitate service provisions to varying groups throughout the County. As members of the Consortium, Cooperating Cities will be instrumental in accomplishing identified goals and activities.

Private Sector

The private sector is an important collaborator bringing additional resources and expertise that can be used to supplement existing services or fill gaps in the system. Lenders, affordable housing developers, business and economic development organizations, and private service providers offer a variety of assistance to residents such as health care, small business assistance, residential mortgage programs, commercial lending and assisted housing, among others.

Discussion:

The County is committed to continuing its participation and coordination with Federal, State, municipal and local agencies, as well as with the private and non-profit sector, to serve the needs of target income individuals and families in the County. In particular, the County will continue to work in close coordination with County departments regarding infrastructure improvements and the provision of services.

The allocation of priorities for housing activities (i.e., rehabilitation), code enforcement and infrastructure improvements were determined through several processes including but not limited to public hearings, outreach and listening sessions and a citizen survey to gauge the activities and projects the public deemed important. The proposed housing activities (i.e., rehabilitation), code enforcement and infrastructure improvements that will take place in low- and moderate-income areas of Clay County are critical to sustaining the quality of life of residents and businesses in the area. This decision allows improvements to be directed to a concentrated area utilizing the limited CDBG resources available. The limiting factor in addressing underserved needs in Clay County are the lack of sufficient CDBG funding allocations as well as other resources to address all the needs.
